TERMS AND CONDITIONS OF REGISTRATION WITH NORTHS BASKETBALL CLUB

Registering as a Playing Member of Norths Basketball Club:

By completing your registration as a player through Basketball ACT's online registration system, You (the Registrant) accepts the terms and conditions of this registration, and You will become a Playing Member of the Norths Basketball Club (the Club). A Playing Member is defined in the Club's Constitution.

Registering as an Associate Member of Norths Basketball Club:

By completing your registration as a Coach, Team Manager or Club Volunteer through Basketball ACT's online registration system, You (the Registrant) accepts the terms and conditions of this registration, and You will become an Associate Member of the Club. An Associate Member is defined in the Club's Constitution.

Bound by Rules:

Upon becoming a member of the Club, You will be bound by the Rules of the Club's Constitution and any Regulations or By-Laws made under it.

Code of Conduct:

It is a condition of registration that the Registrant makes a commitment to abide by the [Norths Code of Conduct](#) policy and the [Basketball ACT Code of Conduct](#) policy.

Fees:

You understand that by completing your registration that You will pay on demand any prescribed or stated fees for Club activities that apply to your category of membership during your period of registration. Such fees may be notified to You verbally or by letter or memorandum or by notice displayed on the Club's website.

When a person registers as a Playing Member with the Club they make a commitment to play and pay for the duration of that season. The Club makes a financial commitment to Basketball ACT (BACT) on behalf of our players when nominating teams and BACT do not refund Norths if players decide not to continue to play for a team during the season. Insurance:

The Club does not carry individual insurance. All registered members are covered under the Basketball Australia State and Territory National Insurance Program. This program is managed by V-Insurance Group (Corporate authorised representative of Willis) as BACT's insurance broker. Please note that insurance cover only applies to members who engage in BACT sanctioned competitions and activities. Members are not covered if they play in a non-affiliated basketball competition.
